

MINUTES of the meeting of the GRASSMOOR, HASLAND AND WINSICK PARISH COUNCIL held on 8 September 2010 at the Grassmoor Community Centre.

PRESENT

QUALITY PARISH COUNCIL PRESENTATION

Mr Brian Wood, Secretary of the Derbyshire Association of Local Councils and Mr Alan Cooke of the Derbyshire Quality Parish Council Accreditation Panel attended the meeting to present the Parish Council with its Quality Parish Council certificate following the Council's successful re-accreditation for the award.

PUBLIC PARTICIPATION

There were no matters taken in public participation.

POLICE/PARISH LIAISON

PSCO Land apologised for not being able to attend the meeting. During the last month there had been 13 crimes in total, 5 of theft, 1 of theft of motor vehicle, 1 of damage to vehicle, 4 of violence, 1 drugs offence and 1 of fraud. This compared to 14 the previous month.

There had been 12 nuisance calls during the same period compared with 8 the previous month. These included 6 incidents of children playing football, 2 incidents of motor bikes on the Country Park and 1 of youths shouting and swearing.

The Clerk reported that he had received a response from the Home Secretary to his letter of 4 May regarding community policing in Grassmoor. The Parish Council were unhappy with the response and the Clerk was asked to respond accordingly.

1231. APOLOGIES FOR ABSENCE

Apologies for absence were received on behalf of Councillors A H Booker, Mrs A Browne and D Chapman.

1232. DECLARATION OF MEMBERS INTERESTS

Councillors I F Barlow, J Bedford, Mrs P J Hemsley, Ms J A Hill and Mrs L Thomas declared personal interests in the item relating to Grassmoor Community Centre (Minute no. 1236 refers).

1233. MINUTES RESOLVED that the Minutes of the meeting of the Parish Council held on 28 July 2010 be confirmed as a correct record and signed by the Chairman.

1234. ITEMS IN EXCLUSION

There were no items to be taken in exclusion.

1235. CHAIRMAN'S ANNOUNCEMENTS

It was reported that the next meeting of the District/Parish Liaison Group was to be held on 17 November. The Parish Council had no items for the agenda. It was noted that the new flats on Mill Lane, would be known as for example, Flat A, 1 Mill Lane. The Parish Council had the option to extend the watering period for the hanging baskets. It was agreed not to take up this option.

It was noted that fundraising events so far for the Leona Seedhouse Appeal had raised £560.00.

1236. GRASSMOOR COMMUNITY CENTRE

The County Council had indicated that they did not wish to move the Library Van location back to North Wingfield Road. The Parish Council reiterated their wish to see it moved. The Clerk agreed to make representations to the County Council.

RESOLVED that the Clerk write to the County Council to request that the Library Van be moved back to its usual location on North Wingfield Road.

1237. BARNES PARK

The Clerk reported that he had contacted the District Council again regarding the order for the replacement litter bin in the Park. It was noted that the area round the play equipment had been particularly bad for broken glass. The Clerk agreed to ask the Streetcleaner to give the area extra attention and to report the problems to the Police.

RESOLVED that (a) the report be noted; and
(b) the Clerk request the Streetcleaner to give the area around the play equipment to clear the broken glass.

1238. CCTV

The Clerk reported that Advance Monitoring Solutions had decided that the only viable option for the CCTV system, given its age and the technical specification, was to replace the entire system at a cost of £27,155.00. A meeting had been held with Advance and the Derbyshire Chamber to discuss the proposal. Arising from the meeting Advance were asked to look at the costs of an alternative system which would use less fixed cameras but more PTZ moving cameras. The costs of the revised proposal which reduced the number of cameras from 17 to 10 were £23,277.05. The revised scheme required a new broadband connection to be installed at a cost of £550.80 per annum payable from the second year. In addition, the new proposal also

had maintenance costs of £3,000.00 per annum also payable from the second year. The Parish Council agreed to place an order for the works proposed in the revised scheme at a cost of £23,277.05. It was also agreed to cancel the arrangement with the Derbyshire Chamber with immediate effect. Advance hoped to be able to undertake the works in mid October.

RESOLVED that (a) the report be noted;
(b) the Clerk be authorised to place an order with Advance Monitoring Solutions for the CCTV system in the sum of £23,277.05; and
(c) the Clerk be authorised to cancel the contract with the Derbyshire Chamber with immediate effect.

1239. MILL LANE ALLOTMENTS

The Clerk reported that he had received complaints about the hedging along the North Wingfield Road boundary encroaching on to the pavement. He had passed the comments on to the Secretary and the works would hopefully be undertaken in the near future.

RESOLVED that the report be noted.

1240. GILL LANE ALLOTMENTS

The Clerk reported that he had placed an order for a “No public right of way” sign with Georgian Signs Limited.

RESOLVED that the report be noted.

1241. GRASSMOOR LAGOONS

Peter Storey apologised for not being able to attend the meeting. The offer remained for members of the Parish Council to be given a tour of the site. It was agreed that this be deferred to a later date when the project was more underway.

RESOLVED that the report be noted.

1242. PARISH PLAN

The Clerk was continuing to work on the Plan.

RESOLVED that the report be noted.

1243. VILLAGE GAMES PROJECT

The Clerk reported that North East Derbyshire District Council had appointed a Village Games Co-ordinator funded by the Community Sports Trust. The role of the post was to develop sporting opportunities in identified villages through activities, coaching and festivals. The Co-ordinator had already visited the Community Centre and the Cricket Club.

Whilst it was outside the remit of this project, it was noted that the area lacked a first class indoor bowls facility.

RESOLVED that the report be noted.
