

MINUTES of the meeting of the GRASSMOOR, HASLAND AND WINSICK PARISH COUNCIL held on 13 July 2011 at the Grassmoor Community Centre.

PRESENT

PUBLIC PARTICIPATION

There were no matters taken in public participation.

POLICE/PARISH LIAISON

PCSO Land attended the meeting to update the Parish Council on crimes and anti-social behaviour which had occurred since the last meeting. There had been 9 crimes reported which compared to 8 the previous month. There had been 1 of criminal damage, 1 of damage to motor vehicle, 1 of theft, 1 of theft from a motor vehicle, 2 of burglary and 3 of violence.

There had been 16 calls relating to nuisance and disorder which compared to 9 the previous month. This included several neighbour nuisance reports on Broom Drive, youths/children and off-road motorbikes causing a nuisance. In respect of one such incident on Mill Lane, a warning letter had been issued.

There had been a distraction burglary at a local shop where the CCTV system had been used to identify those responsible.

PCSO Land indicated that he was planning a series of activities with young people in the village including a "Youth Café" at the Community Centre. The Parish Council thanked PCSO Land for his work in general and in particular, his work with young people.

1426. APOLOGIES FOR ABSENCE

Apologies for absence were received on behalf of Councillors A H Booker and K Hemsley.

1427. DECLARATION OF MEMBERS INTERESTS

Councillors I F Barlow, Mrs J Bedford, Mrs P J Hemsley and Ms E A Hill declared a personal interest in the item relating to Grassmoor Community Centre (Minute no. 1431 refers). Councillor Mrs J Bedford declared a personal interest in the item relating to Mill Lane Allotments (Minute no. 1434 refers).

1428. MINUTES RESOLVED that the Minutes of the meeting of the Parish Council held on 8 June 2011 be confirmed as a correct record and signed by the Chairman.

1429. ITEMS IN EXCLUSION

There were no items to be taken in exclusion.

1430. CHAIRMAN'S ANNOUNCEMENTS

There were no Chairman's announcements.

1431. GRASSMOOR COMMUNITY CENTRE

The Centre Coordinator's report to the last meeting of the Management Committee was circulated for the Parish Council's attention.

RESOLVED that the report be noted.

1432. BARNES PARK

The Clerk reported that the seats had been removed from the swings in the Park presumably by the District Council, although the Parish Council had not been notified. The estimated cost of replacement was £125.00 per seat. It was agreed that the Clerk arrange for the seats to be replaced.

RESOLVED that the Clerk arrange for the swing seats to be replaced.

1433. CCTV

The Clerk reported that he had requested a cost from Advance for the works to hard wire the camera. The cost had not yet been received.

The Clerk was asked to enquire whether the Derbyshire Chamber had written to local businesses contacted by Business Watch as had been agreed at the meeting with the Chamber.

RESOLVED that (a) the report be noted; and
(b) the Clerk ask if the Derbyshire Chamber had written to local businesses contacted by Business Watch.

1434. MILL LANE ALLOTMENTS

Members of the Parish Council had judged the Best kept Allotment on 3 July. Plot 60/61 had won the first prize, plots 1 and 18 had jointly won second place and plots 10 and 17 had come joint third. The Primary School had also been awarded a £50 prize for outstanding achievement. It was agreed that the Clerk arrange for plaques for the winners.

RESOLVED that (a) the report be noted; and
(b) the Clerk arrange for plaques to be purchased for the winners.

1435. GILL LANE ALLOTMENTS

The Clerk reported that the gate to the allotments on Gill Lane needed to be re-hung.

RESOLVED that (a) the report be noted; and
(b) the Clerk arrange for the gate to be re-hung.

1436. GRASSMOOR LAGOONS

Peter Storey, Derbyshire County Council and Simon Jackson and Peter Russell from Remedex, attended the meeting to update the Parish Council on the progress on the works to clean-up the Lagoons.

It was noted that the consultations were almost complete and the work to answers the outstanding questions had been completed and they had been submitted to the County Council. It was hoped that the application would be considered by the Planning Committee in early September.

The costs of the project had risen but were within the grant limits. It was noted that whilst there would still be contamination in the ground, the levels of this contamination were well below the levels that would be considered problematic and dangerous.

RESOLVED that the report be noted.

1437. GRASSMOOR COUNTRY PARK PROJECT

The Clerk reported that as agreed at the last meeting, he had contacted the County Council to “express an interest” in the Cricket and Football Clubs re-locating to the Country Park.

The County Council had indicated that they felt the idea warranted “serious consideration” and they wished to discuss the idea further. It was agreed that the Clerk arrange a meeting of the Leader Funding Group to talk about the proposal in more detail.

RESOLVED that (a) the report be noted; and
(b) the Clerk arrange a meeting of the Leader Funding Group.

1438. PARISH PLAN

There were no matters relating to the Parish Plan to report.

RESOLVED that the report be noted.

1439. HASLAND CEMETERY

The Clerk reported that the District Council provided and managed Hasland Cemetery and that the Parish Council made a contribution to its upkeep. Other Parish Councils such as Clay Cross, Shirland, Killamarsh and Eckington provide their own cemeteries.

Each Parish Council is the local burial authority and predominantly Parish Councils provide and operate their own cemeteries. However, Grassmoor and Temple Normanton don't and the District Council has undertaken this function and they contribute towards the running costs. The Cemetery in 2010\11 cost £53,647 to operate and the Parish Council's contribution was £8,627.

The Cemetery had been called Hasland Cemetery since approximately 1836 when it was established. The District Council were not aware of any previous name change requests. If the Parish Council wished to pursue a name change this would involve a full consultation period and would probably involve the payment of legal fees.

The Clerk was asked to ascertain the cost of burial for non-Parish residents.

RESOLVED that (a) the report be noted; and
(b) the Clerk was asked to ascertain the cost of burial for non-Parish residents.

1440. FUTURE OF SCHOOL SPORT

The Parish Council had been invited to participate in the School Sport Partnership.
