

MINUTES of the meeting of the GRASSMOOR, HASLAND AND WINSICK PARISH COUNCIL held on 13 March 2013 at the Grassmoor Community Centre.

No crimes and nuisance and disorder figures had been provided. It was noted that the vulnerable individuals living on Broom Drive and Wenlock Walk had been taken off monitoring by the Police.

1838. CHAIRMAN'S ANNOUNCEMENTS

Councillor Ann Browne had thanked the Parish Council for their kind regards and also for the bouquet of flowers. She hoped to be able to attend meetings again from May onwards.

The Clerk reported that a dog bin had been ordered for the walk way between MacDonald Close and Chapman Lane. Local residents had requested that another dog bin be installed at the other end of the walk way. It was decided not to purchase the additional bin at this stage.

The District/Parish Council Liaison Group was to be held on 20 March 2013 at 6.00pm at the District Council Offices.

1839. GRASSMOOR COMMUNITY CENTRE

The Clerk reported that he had asked Helena Stubbs from Rural Action Derbyshire for details of any other village halls or community centres which had switched to using solar panels to produce its energy. It was noted that County Councillor Chapman had given a grant to the Community Centre of £1,500 from the Community Leadership Fund.

1841. CCTV

The Clerk reported that all the cameras with the exception of the one at Winsick were now working again. The camera at Winsick required an ADSL which the Clerk was investigating. Three cameras, including one owned by the School needed replacement. It was agreed that the School be charged £300.00 for the camera replacement. NW Systems had provided training to PCSO Land on the new system and the Clerk had received full details of the system specification. Community Centre staff would monitor the cameras for faults.

1842. MILL LANE ALLOTMENTS

Three members of the Allotment Committee attended the meeting to discuss the Garden for All project. The Parish Council agreed to assist the Garden for All project through the joint working group which had been set up but which had not yet met. The Garden for All members however, would retain responsibility for the project and its funding. The Committee was asked to prepare a list of issues with the project which needed to be resolved.

The Allotment Committee members had some concerns regarding the entrances to the Allotments which they felt could be improved by being widened. It was suggested that such improvements could be taken in to account as part of the wider project. The Allotment Committee were also concerned about gaps in the hedging. The Parish Council agreed to look at assisting with funding replacement hedging if no alternative funding could be found.
